As part of your Program License, you will receive many benefits which include the assistance of reservation specialists and access to an unlimited number of reservations for condominium unit rental accommodations through our website, as well as unlimited access to condominium unit rental accommodations classified as "Last Minute Condos" (i.e., condominium unit rental accommodations that may be available forty-five days or less prior to desired travel dates), which must be made in seven day increments. All reservations are based on availability and must be made either on-line through our website at www.travelchoiceinternational.com or directly with the Reservation Center at **(866) 824-4753**. We recommend that standard reservation requests be made at least ninety (90) days in advance of the desired reservation time. However, short notice reservations may be available by selecting from the available "Last Minute Condos" inventory listed on our website.

All reservations are made on a first come, first serve, space availability basis. Licensees will need to present a valid credit card number in order to pay for and confirm travel or other benefit services. Licensees will be responsible for paying all applicable fees at the time of making the reservation, including the purchase price, applicable taxes, port charges, resort fees and other fees imposed by the various providers of travel and other related benefits.

Hotel and condominium unit reservations can be made on-line through the Program website ("**Website**"). Available inventory may be viewed and reserved on a "real time" basis. All reservations are final, and may not be canceled by the Licensee. The Program Administrator will provide Licensee with a confirmation via electronic mail showing the resort name, location, date, unit or room size, occupancy limit, and all other relevant information regarding the hotel or condominium unit reservation. The person named on the confirmation must be present in order to check-in and obtain the reserved accommodations. All reservations and use of the various hotel and resort properties are subject to each hotel and resort properties' rules and regulations.

Licensees may use the Website to view, but not reserve, available inventory and pricing for cruise reservations, all-inclusive resort stays, air transportation, car rentals, golf and vacation packages, and all other Program Benefits that are provided through the Website. All reservations for these Program Benefits, excluding hotel and condominium unit accommodations, must be made through the Reservation Center. Available inventory and pricing information is currently not provided on a "real time" basis for Program Benefits other than the hotel and condominium unit reservations. Therefore, this information is subject to change and should not be relied upon as being fully accurate, as this inventory is subject to being reserved by a Licensee at any time. In order to assure the availability of the inventory and prices viewed via the Program website, Licensee should contact the Program Administrator by contacting the Reservation Center to confirm this information.

You will also be entitled to receive all other Program Benefits that are part of your Program License.
